### **Eligible Customers for Master Titanium Photo Debit Card**

- Individuals excluding Minor (aged below 10) and Illiterate persons
- Students aged more than 16 years
- SB Dynamic Youth account holders aged more than 17 years.
- Joint account holders – with mode of operation (E or S) or Any one (F or S)
- Karta of Hindu Undivided Family accounts
- Proprietor of Proprietorship concern

### **Eligible Accounts:-**

- Savings Bank Accounts – Except the following accounts
  - Ø No frill accounts (SB Janatha and Simple Small Savings Accounts – SSSSB)
  - Ø TMB Simple Savings Bank Accounts (SSSBA)
  - Ø SBJDY (Jan Dhan Yojana) Accounts
- Current Accounts
- Overdraft Accounts – Personal Overdraft and OD against the security of Term Deposit, Government securities and Gold.
