NOTICE OF CANDIDATURE OF DIRECTORS AT THE 97[™] ANNUAL GENERAL MEETING

Composition of the Board

The present composition of the Board is 11 Directors (including the two RBI nominees) out of which one of the Directors is the Managing Director & CEO of the Bank. All the Directors except RBI Nominees and MD & CEO are deemed to be retiring at the commencement of proposed AGMs and the Bank had invited nomination in respect of the above. In terms of the provisions of Section 149 of the Companies Act, 2013 read with applicable provisions of the Banking Regulation Act, 1949, the required Composition of the Board other than the MD & CEO and two RBI nominees are as under:
